NON-TRANSFERABLE LIMITED CONSUMER WARRANTY

Directed Electronics, Inc. (Directed) promises to the original purchaser that the automotive video monitor and/or source unit(s) (the Product), excluding accessories, purchased and installed from a Directed authorized dealer within the ninety (90) days after purchase of the new vehicle, in which the Product is installed, is free from defects in materials or workmanship under normal use and conditions for a period of three (3) years from date of purchase or the first 36,000 miles as registered on the new vehicle's odometer reading at time of delivery of the Product for warranty service, whichever occurs first. Product purchased or installed more than ninety (90) days after the new vehicle is purchased are warranted for a period of one (1) year from date of purchase of the Product.

Directed promises to the original purchaser that all video accessories will be free from defects in materials and workmanship under normal use and condition for a period of ninety (90) days after the date of purchase. A sales receipt and/or warranty registration card is required to provide proof of date of purchase of the Product or accessories.

Should the Product be determined defective during the applicable warranty period, the Product will be repaired or replaced with a new or comparable reconditioned part(s), at Directed's option. To obtain warranty service, the Product must be returned to a Directed authorized dealer along with proof of purchase and installation.

Note: This warranty does not cover labor costs for the removal and reinstallation of the Product. **IN ORDER FOR THIS WARRANTY TO BE VALID, YOUR PRODUCT MUST BE SHIPPED WITH PROOF OF PURCHASE AND INSTALLATION BY AN AUTHORIZED DIRECTED DEALER. ALL PRODUCTS RECEIVED BY DIRECTED FOR WARRANTY REPAIR WITHOUT PROOF OF DIRECTED DEALER INSTALLATION WILL BE DENIED.**

Important Notes

1. Before operating your A/V selector, please read these instructions carefully.
2. Retain this manual for future reference.
3. Do not remove any WARNING stickers on the unit.
4. Ensure that A/V selector is mounted in an area where foreign objects or condensation can intrude into the selector.
5. This unit is designed to operate off 12VDC (vehicle battery). Verify the battery voltage of the vehicle prior to installation.
6. Ensure that all wiring is properly connected before operating the unit.
7. The engine of the vehicle should be left running when operating the A/V selector, to preclude running the battery down.
8. Mount the A/V selector switch in an area that does not interfere with the driver's operation of the car and in an area that will not injure the driver or passengers during an accident.
9. Do not disassemble the unit. There are no serviceable parts within the unit.
10. Before replacing a blown fuse, turn the unit off and disconnect all power. Ensure the replacement fuse is of the same rating as the fuse being replaced.
11. If during operation the unit overheats or malfunctions, turn off the power and contact your dealer. Do NOT disassemble the unit, there are no user serviceable parts in the unit.
12. The rated operating temperature range of the unit is 0° to 70° C. Cool or warm the vehicle to within this temperature range prior to unit operation.

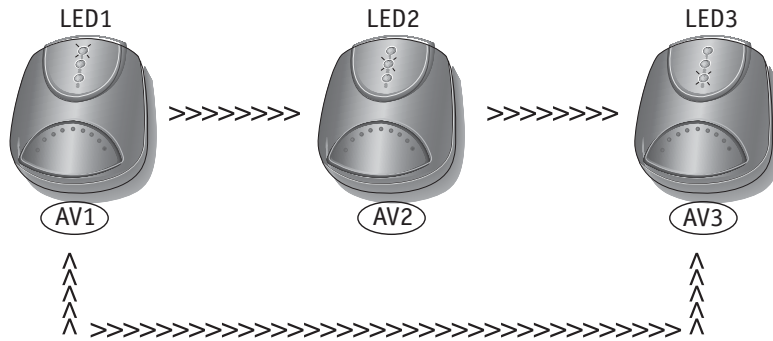

This unit provides a 3-input and 3-output A/V selector system, with 3 hard wire remotes. The system is designed so that each monitor can independently control the video sources

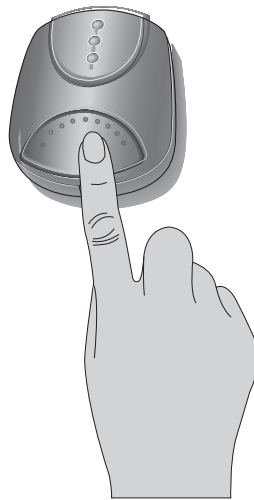

Operation

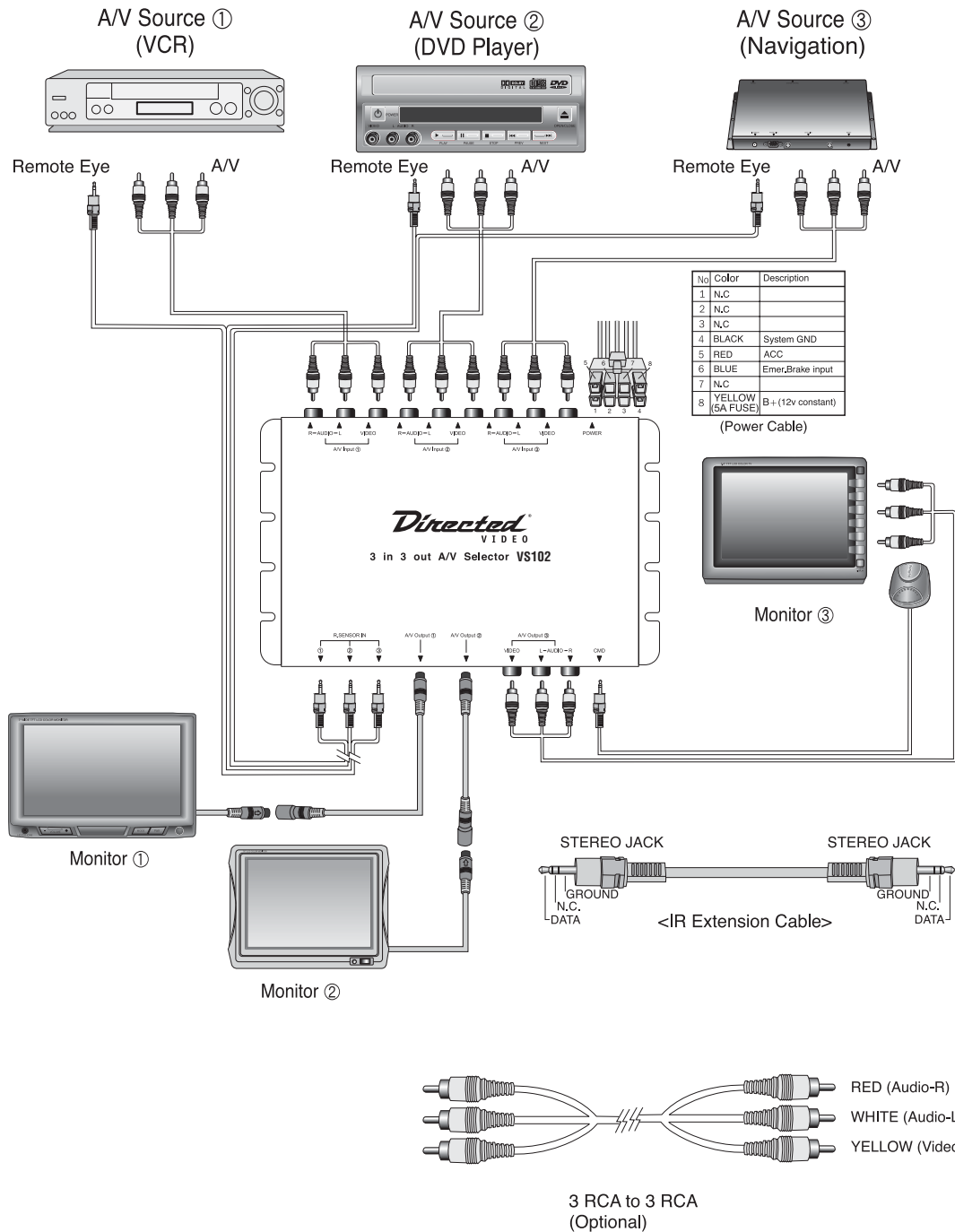
Pressing the button on the remote source selector switch will scroll the LED down consecutively. Each LED represents the video input source to be displayed to the video monitors.

NOTE: The BLUE wire of the Power Harness connects to the emergency brake. All A/V outputs are **enabled only when this wire is grounded.**

The 5A fuse, that is referenced on the POWER CABLE wiring chart, is located inside the attached noise filter box.
